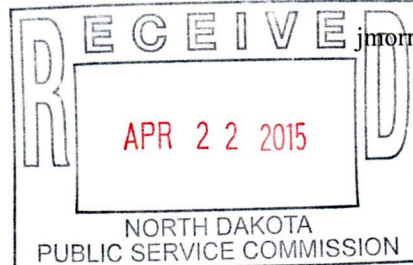

ARTICLES OF ORGANIZATION
OF
BRIDGER PIPELINE LLC

The undersigned person hereby promulgates these **Articles of Organization** in order to form a Limited Liability Company under the Wyoming Limited Liability Company Act as follows, to wit:

I. The name of the Limited Liability Company is:

BRIDGER PIPELINE LLC

II. The period of its duration shall be:

PERPETUAL UNTIL DISSOLVED BY AGREEMENT OF THE MEMBERS, UNLESS A SHORTER TERM IS SPECIFIED BY THE STATE OF WYOMING LIMITED LIABILITY COMPANY ACT, AS IT MAY BE AMENDED FROM TIME TO TIME, IN WHICH CASE SAID STATUTE SHALL GOVERN THE TERM HEREOF.

III. The purpose for which the limited liability company is organized:

ENGAGING IN THE BUSINESS OF TRANSPORTING CRUDE OIL AND/OR PETROLEUM PRODUCTS, AS WELL AS ENGAGING IN ANY OTHER BUSINESSES, DOING ANY ACTS, OR EXERCISING ANY POWERS IN WHICH THE MEMBERS DESIRE TO SO ENGAGE, DO, OR EXERCISE, WHICH IS ALLOWED BY THE WYOMING LIMITED LIABILITY COMPANY ACT, WHETHER WITHIN OR WITHOUT THE STATE OF WYOMING.


