Economic Development Foundation presents recruitment campaign

The communities in Oliver and Mercer counties draw many people to work in the energy industry and the power stations in the area, but they have a problem retaining these workers as permanent residents. Many come to the area for a little while to make money before moving on, while others commute from Bismarck or other areas.

Terry Fleck, from the North Dakota Economic Development Foundation, spoke with the Mercer County Economic Development board Wednesday, May 17, to discuss strategies for recruiting and retaining new people within the area. With him was Wayde Sick, director of workforce safety at the foundation.

Fleck stated that the greatest export for North Dakota is its young people, and that it is his purpose to help counties around the state bring back as many of these young people as possible. He mentioned specifically targeting military families, as servicemen and women are willing to relocate since it has become a part of life for them.

Sick cited a recent study in which the four things that are most likely to bring people back to their hometowns were found to be aesthetics, community openness, education opportunities, and social offerings. North Dakota can offer many of these things in its communities, and individual communities should work on enhancing these four things as much as possible if they hope to not only attract people to return to their hometowns, but to re-

tain them for years to come.

One of the key successes of the N.D. Economic Development Foundation so far has been the establishment of a recruitment network. This network avidly searches for employment opportunities by communicating with one another about job openings. One possible benefit of the network is that, if a person moves to a community to work in the energy field, the network will be able to identify potential employment possibilities for a spouse, which encourages the family to actually settle down and live here.

Fleck also said that North Dakotans are their own worst enemy when it comes to recruitment, due to the inside jokes they use. For example, if someone from down south was considering moving up to work in the energy industry, North Dakotans would likely laugh about the person's ability to last through the winter. Fleck said the state needs to promote itself and develop its own image to attract out-of-state people to come here.

The economic development board brought up several points related to education funding and what image the state in general, as well as Oliver and Mercer counties, should use to promote themselves. Fleck addressed these concerns and stated that he still believes North Dakota has lots of potential for future growth.

Fleck noted that the foundation itself does not make presentations due to limited resources, but will gladly provide information communities can use and display during the events.

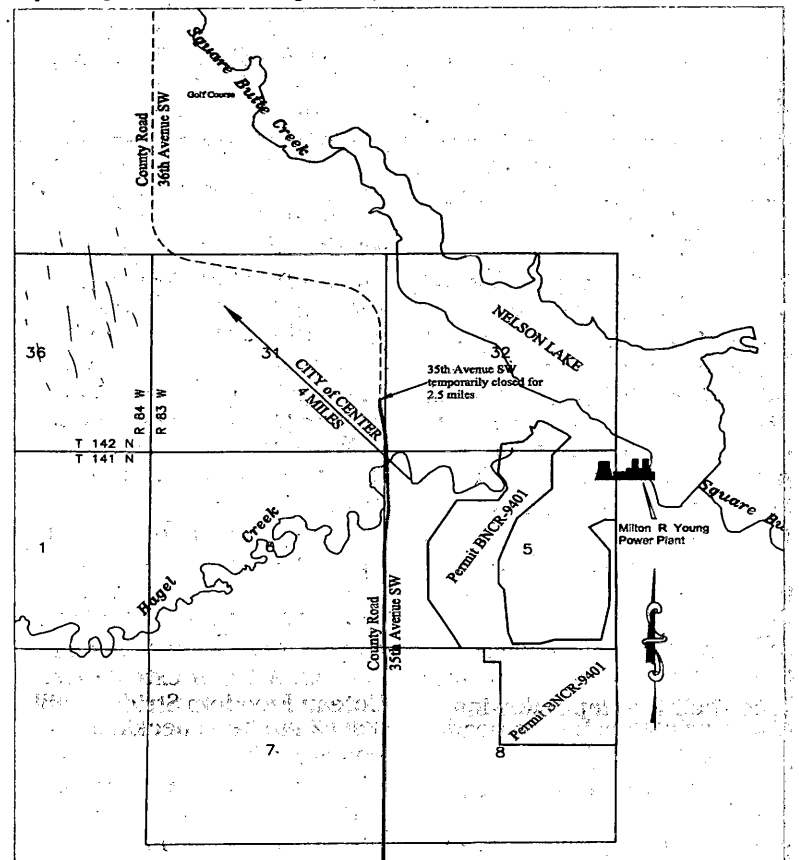

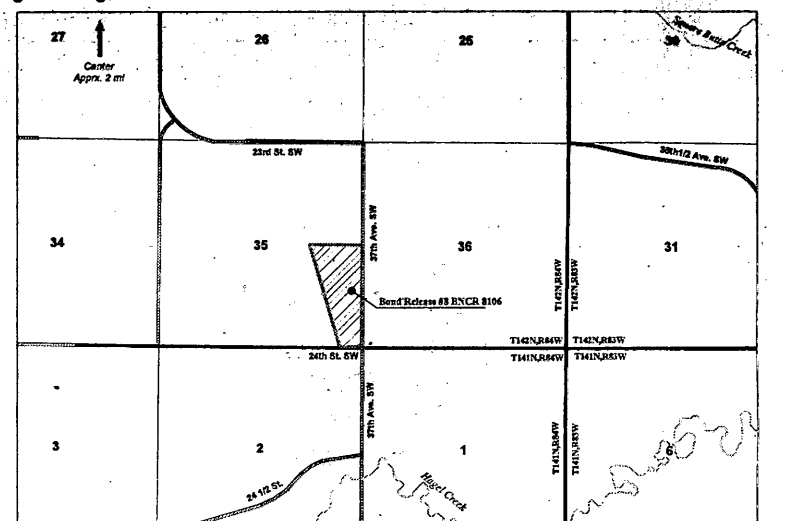

LEGAL NOTICE NOTICE OF APPLICATION TO RELEASE PERFORMANCE BOND

BNI Coal, Ltd., 2360 35th Avenue SW, Center, ND 58530-9499 has submitted an application to the North Dakota Public Service Commission to release the following tract of land from all phases (I-IV) of bond release and all remaining reclamation liabilities: 58.23 acres in Permit BNCR-8106 in the SE 1/4 of Section 35, T142N, R84W in Oliver County. Permit BNCR-8106 was approved on July 19, 1983. The bond release tract was initially permitted under Permit 24, approved on December 5, 1973 and Permit 37, approved on September 20, 1976. No monetary release is requested since the bond amount is based on the worst-case reclamation condition for the consolidated bond area that includes Permits BNCR-8106, BNCR-9702, BNCR-8202 and BNCR-8602. The current bond amount is \$34,139,439.00. The bond release tract is described below and depicted on the attached map. Initial disturbance on the bond release tract occurred in 1974 in preparation for coal removal. The mining of lignite began in 1975 and continued

through 1983. Reclamation consisting of grading, SPGM respread, and seeding occurred between 1980 and 1989. The post mine land uses for this tract consist of 53.05 acres of tame pasture and 5.18 acres right of way that includes a portion of the reclaimed county road (37th Ave. SW). No mining disturbance occurred on 1.46 acres along the southern boundary of the tract.

Copies of the bond release request and supporting documents are on file at the Oliver County Auditors Office, Center, ND 58530, and the Office of the Director of the Reclamation Division, ND Public Service Commission, 600 East Boulevard Avenue, Bismarck, ND 58505-0480. Any person having a valid legal interest, which is or may be adversely affected by release of the bond has the right to file written comments or objections, may request an informal conference or public hearing regarding the proposed releases from bond with the North Dakota Public Service Commission, 600 East Boulevard Avenue, Bismarck, ND 58505-0480 within thirty (30) days after the last publication of this notice.
