

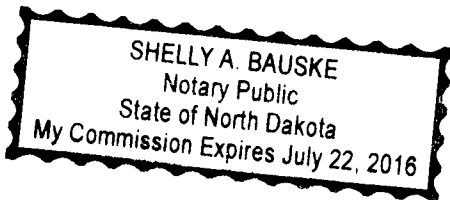

**ORDER GRANTING REQUEST
TO DISCONTINUE BUSINESS**

May 27, 2015

Walton Ag Services, Inc. dba Walton Ag Services operates a public grain warehouse at Englevale, North Dakota, under license number 1122 issued by the Public Service Commission under the provisions of North Dakota Century Code Chapter 60-02.

On April 10, 2015, the Commission received notice that the insurance policy issued to Walton Ag Services, Inc. dba Walton Ag Services would be cancelled on June 9, 2015. North Dakota Century Code section 60-02-35.1 provides that unless the warehouseman files proof of new or renewed insurance at least thirty days before the existing policy ceases, the Commission, without hearing, shall immediately suspend the warehouseman's license and the suspension may not be removed until a new policy has been filed and approved by the Commission.


On May 11, 2015, Walton Ag Services, Inc. dba Walton Ag Services filed a request to discontinue business.

Order

The Commission orders:

1. Warehouse license number 1122 issued to Walton Ag Services, Inc. dba Walton Ag Services is cancelled effective May 11, 2015;
2. Business at Englevale, North Dakota, is discontinued effective May 11, 2015 and Walton Ag Services, Inc. dba Walton Ag Services shall not conduct any further business under license number 1122; and
3. Walton Ag Services, Inc. dba Walton Ag Services shall return public grain warehouse license number 1122 to the Commission.
