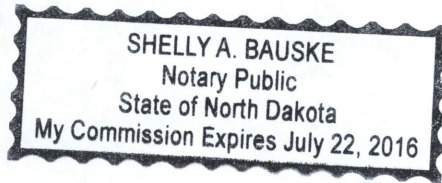

Submitted with the application was a statement by Kevin Klosterman that he desires electric service to be provided by the applicant.




Otter Tail Power Company has made a prima facie showing that it should serve the customer.

On June 17th, the Commission issued a Notice of Opportunity for Hearing with the incorrect service location. Service is to be provided at a point located in:

Any interested party has the right to file written objection, based on the issue of public convenience and necessity, with the Commission by **August 26, 2015**, and the matter will then be set for hearing. If no objections are received by that date, the application may be granted as requested.
