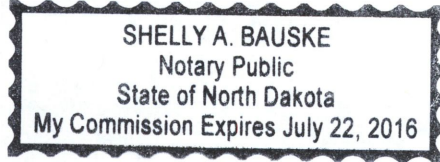


Submitted with the application was a statement by Crestwood Crude Logistics LLC that it desires electric service to be provided by the applicant. Service is to be provided at a point located in:

North Dakota.**


Montana-Dakota Utilities Co., a Division of MDU Resources Group, Inc. has made a prima facie showing that it should serve the customer.
