Dear Mr. Nitchke:

Enclosed for filing with the Public Service Commission of North Dakota are amended Sheet Nos. 2, 50, and 51 to First Communications, LLC's ("First") North Dakota switched access price list, North Dakota Price List No. 2, for incorporation into the Company's Price List.

This submission is made pursuant to the Federal Communications Commission's ("FCC") *Report and Order and Further Notice of Proposed Rulemaking*, in Docket Nos. WC Docket No. 10-90, et al., FCC 11-161,¹ *Second Order on Reconsideration* in Docket Nos. WC Docket No. 10-90, et al., FCC 12-47,² and Sections 51.911 and 61.26(c)³ of the FCC's rules, 47 C.F.R. §§51.911, 61.26(c).

On June 16, 2015, CenturyLink Operating Companies ("CenturyLink") amended Section 6 of the Companies' Tariff F.C.C. No. 11, *inter alia* reducing local switching and shared trunk port end office rates. First complies with the above cited orders and rules by reducing its terminating intrastate access rate and intrastate Toll VoIP-PSTN traffic rates through adoption of the corresponding CenturyLink amended terminating access rates set forth in the CenturyLink's Tariff F.C.C. No. 11, effective July 1, 2015. The Company's F.C.C. Tariff No. 3 may be viewed at <https://apps.fcc.gov/etfs/public/lecTariffs.action?idLec=484>. A July 1, 2015 effective date is requested to enable the Company to comply with the above cited orders and rule.


