Hiland Partners, LLC (Hiland) received a letter and post construction inspection report, dated April 20, 2017. Hiland performed reclamation activities on May 22, 2017. Photographic evidence and descriptions of these reclamation activities was provided to the North Dakota Public Service Commission. A letter was received on June 15, 2017 requesting additional photographs of the reclaimed areas at the end of 2017 growing season. Due to the slower than predicted vegetation growth at reclaimed sites 62 and 65 in 2017; continued monitoring was required. Photographs were taken on June 15, 2018 at reclaimed sites 62 and 65. Photos of all reclaimed areas are provided in Attachment A.

Hiland believes the sites have properly revegetated, also have received no landowner notifications, and respectfully requests that these actions be considered final and deemed completed. If the commission agrees with this statement written correspondence recommending closure these items is requested by Hiland.

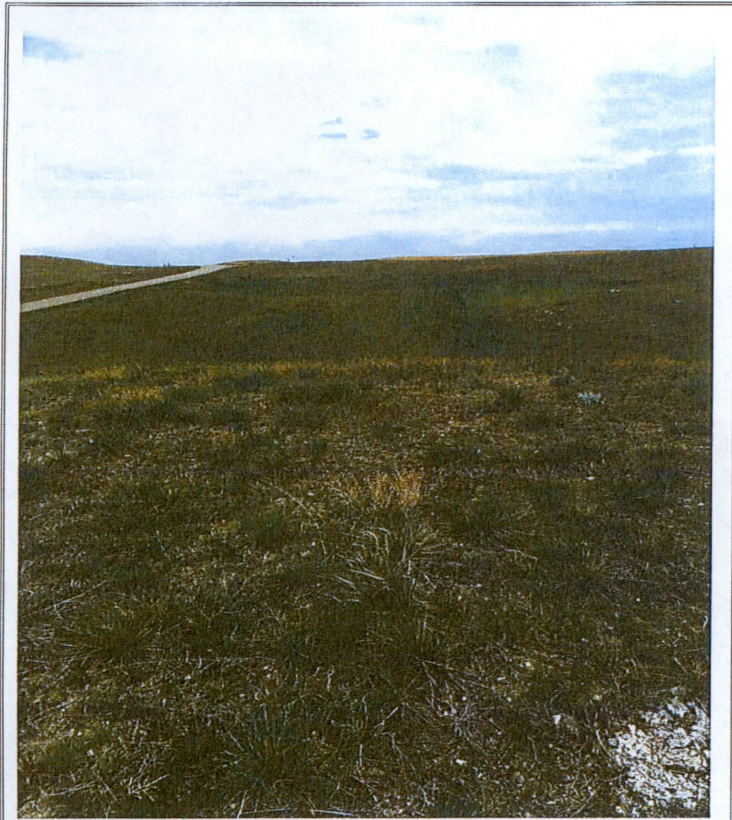


Photo 1 – Addresses Recommendation 62

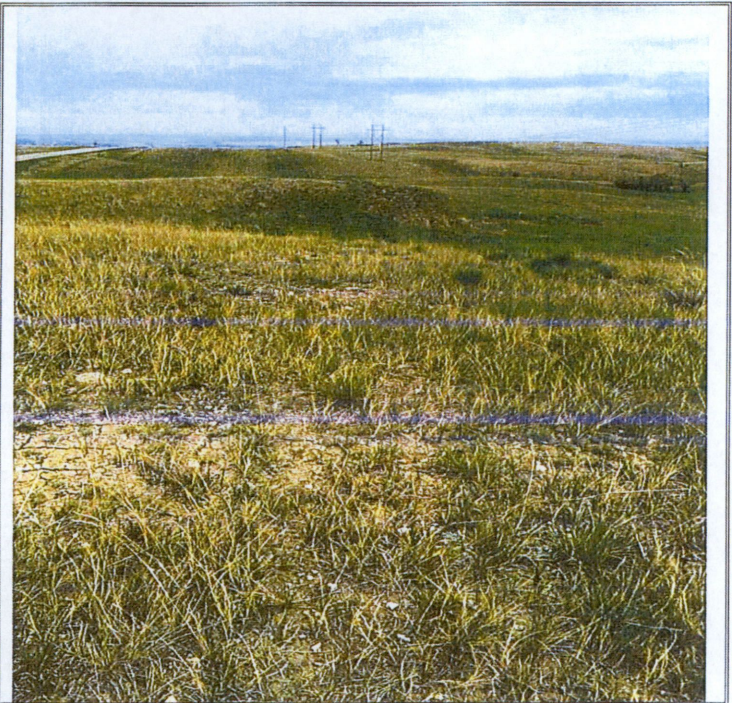
