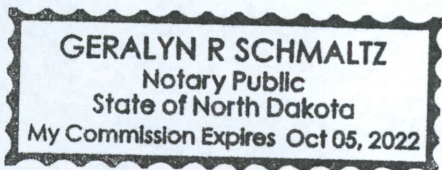

ORDER LIFTING SUSPENSION AND REINSTATING WAREHOUSE LICENSE

March 27, 2019

Preliminary Statement

Arthur Glasoe & Lance Glasoe dba Wildrose C & D operates a licensed public grain warehouse at Wildrose, North Dakota, under license number 891, issued by the Public Service Commission under the provisions of North Dakota Century Code Chapter 60-02.

On January 7, 2019, the Commission received a cancellation notice for the Certificate of Insurance on Grain for Arthur Glasoe & Lance Glasoe dba Wildrose C & D effective March 8, 2019.

On February 8, 2019, as provided in North Dakota Century Code section 60-02-09.1, the Compliance Division suspended the company's warehouse license effective February 8, 2019 for failure to file replacement insurance at least thirty days before liability ceases on the existing insurance.

Also, on February 8, 2019, the Compliance Division notified Arthur Glasoe & Lance Glasoe dba Wildrose C & D that it had until March 8, 2019 to procure and file replacement insurance.

On February 28, 2019, the Commission issued an Order Suspending Warehouse License and Notice of Opportunity to be Heard.

On March 7, 2019, the Commission received proof of insurance on grain.

The insurance requirements have now been met.


