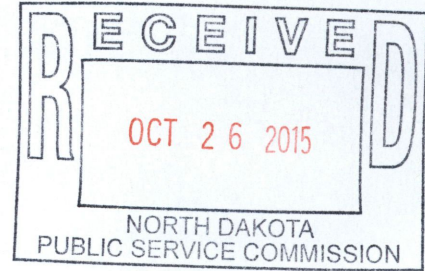

The materials delivered to you include:


1. An audio CD of the recording of the hearing;
