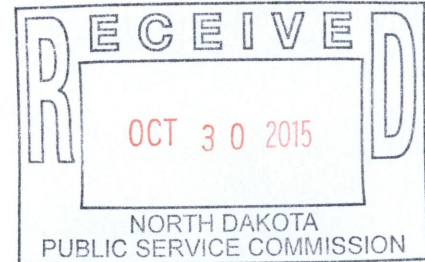

The hearing in the Plains Pipeline matter, PU-15-614, was held as scheduled in Williston on October 29, 2015, at the Ernie French Center.
