

Pursuant to North Dakota Century Code § 49-22-07.2, Brady Wind, LLC (“Brady Wind”) hereby makes its application to the Public Service Commission (“Commission”) for a waiver of certain procedures and time schedules set forth in Chapter 49-22 which require two publications of the hearing over a certain time frame; Brady Wind requests that there only be one publication of the hearing notice, and to shorten the time frame for all hearings; in order that the hearings be held twenty (20) days after today, being March 16, 2016.

This waiver application is submitted on the basis that the projects will produce minimal adverse effects.

This application for a waiver of procedures and time schedules is being made to the Commission should the Commission grant Concerned Citizens of Stark County’s Motion for Continuance. If the Motion for Continuance is denied, Brady Wind will withdraw this application.

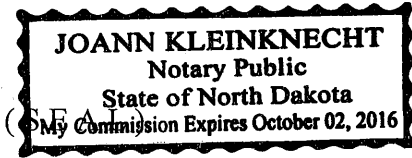
