

This is made to amend contract # PU-756-16 (Contract) between the State of North Dakota, acting through its North Dakota Public Service Commission, Public Utilities Division (STATE) and Wenck Associates, Inc. (CONTRACTOR).

The parties agree to the following terms and conditions and expressly agree that if any of the following terms and conditions conflict with any of the terms and conditions of the Contract, then, notwithstanding any term in the Contract, the following terms and conditions govern and control the rights and obligations of the parties.

The parties agree to amend the Contract as follows:

Contract Section 3, Term of Contract. The Contract commenced on February 10, 2016, to expire on December 31, 2018 with an option to extend the contract up to three times for an additional period of time not to exceed 12 months per extension.

The parties agree to extend the Contract for an additional twelve (12) months, therefore, the Contract is amended to change the expiration date to December 31, 2019.

All other terms of the Contract remain in effect.

This Contract Amendment is not effective until fully executed by all parties.
