Request To:

Operate a hopper scale that deviates from North Dakota Weights and Measures rules as follows:


- 1) Less unobstructed clearance than required (3') on all four sides of the scale to facilitate testing with large weights [N.D. Admin. Code § 69-10-02-26].

Temporary Variance Permit Conditions:

- The scale must be placed in service by a registered service company at acceptance tolerance as identified in NIST Handbook 44 G-T.1;
- After being placed into service initially, the scale must be retested and adjusted to acceptance tolerance by a registered service company in April 2016 and October 2016;
- The service company test reports must be submitted to the Commission within seven working days of the test date and a copy retained by Northwood Equity Elevator Company;
- The service company test report must include both the "as found" and "as left" readings;
- Except for the specific variance granted by Permit No. 503, the scale must be operated according to all applicable North Dakota Laws and Rules;
- The enclosed variance permit must be posted near the designated scale in a place clearly visible to the public; and
- Failure to comply with the variance permit conditions may result in revocation.
