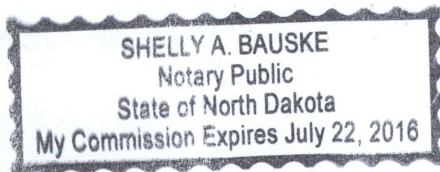

NOTICE OF FILINGS AND NOTICE OF OPPORTUNITY FOR HEARING

January 5, 2016

On December 21, 2015, the Commission issued an erroneous NOTICE OF FILINGS AND NOTICE OF OPPORTUNITY FOR HEARING for the captioned case. Consequently, the December 21, 2015 notice has been rescinded, and the Commission is issuing this notice.

ONEOK Bakken Pipeline, L.L.C. (ONEOK) has filed an application to amend the Second Reissued First Amended Certificate of Corridor Compatibility No. 122 and the Second Reissued First Amended Route Permit No. 131 issued by the Commission on December 4, 2013 in Case Number PU-13-738. ONEOK is proposing to add a pump station, extending outside of the approved corridor in Section 3 of Township 148 North, Range 102 West, of McKenzie County, as shown on the attached map.

ONEOK has also filed an application for waivers of procedures and time schedules established under North Dakota Century Code sections 49-22-07.2, 49-22-08, 49-22-08.1, 49-22-13, and North Dakota Administrative Code section 69-06-01-02 and chapter 69-06-06, requiring separate filings, notices, publications, hearings, and certain time schedules on such applications.

The issues to be considered in the application for waiver of procedures and time schedules are:

1. Are the proposed facilities of such length, design, location, or purpose that they will produce minimal adverse effects and that adherence to applicable procedures and time schedules may be waived?
2. Is it appropriate for the Commission to waive any procedures and time schedules as requested in the application?

The issues to be considered in applications for a certificate of corridor compatibility and route permit are:

1. Will the location and operation of the proposed facilities produce minimal adverse effects on the environment and upon the welfare of the citizens of North Dakota?

2. Are the proposed facilities compatible with the environmental preservation and the efficient use of resources?
3. Will the proposed facility locations minimize adverse human and environmental impact while ensuring continuing system reliability and integrity and ensuring that energy needs are met and fulfilled in an orderly and timely fashion?

If found that a waiver is appropriate, the Commission may proceed to consider the application for a corridor certificate and route permit without further notice or hearing. Those interested are invited to comment on the application in writing.

Persons desiring a hearing must file a written request identifying their interest in the proceeding and the reasons for requesting a hearing. **Comments and requests for hearing must be received by February 4, 2016.** If deemed appropriate, the Commission can determine the matter without a hearing.

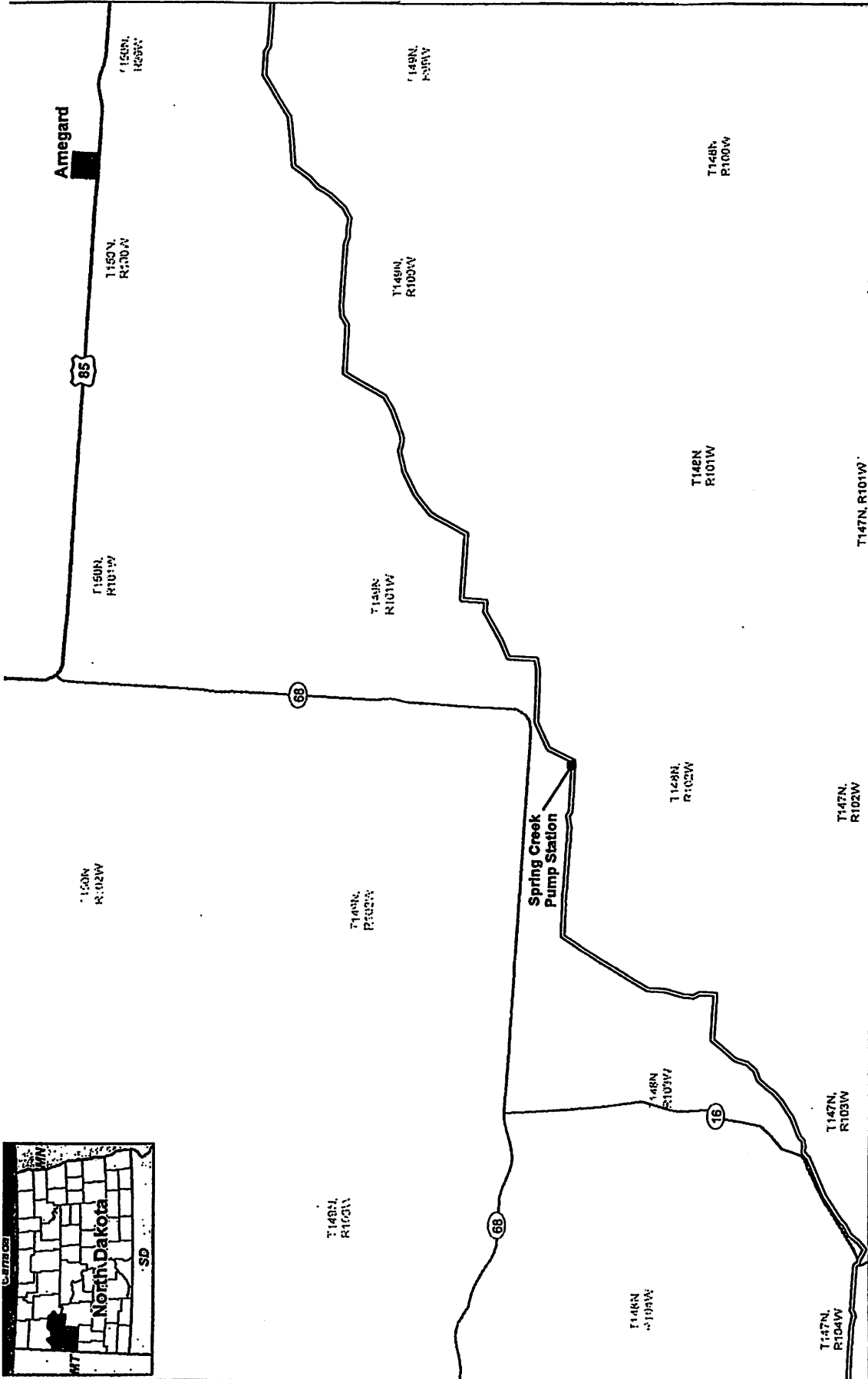
