Sacagawea Pipeline Projects:

- Sacagawea Pipeline (PU-15-114)-McKenzie and Mountrail Counties
- Johnson’s Corner Connector (PU-15-744)- McKenzie County
- Palermo to Enbridge (PU-15-670)- Mountrail County

Project Tree Counts: Listed below are the tree/shrub replacement counts (Tree Count Spread Sheets attached). Tree Count Spread Sheets attached.

- Sacagawea Pipeline: total of 595 trees/shrubs were removed during construction of the pipeline necessitating the replanting of 1190 trees/shrubs.
- Johnson’s Corner Connector: a total of 519 trees/shrubs were removed during the construction of the pipeline necessitating the replanting of 1038 trees/shrubs.
- Palermo to Enbridge: No trees/shrubs were removed during the construction of the pipeline.

Tree/Shrub Mitigation Plan: Sacagawea Pipeline Company, LLC will contract with the Natural Resource Conservation Service offices in both McKenzie and Mountrail counties whose soil conservation offices each have programs whose task/goal is to plant and monitor new trees in their respective counties. NRCS officials meet with individual landowners to develop a plan for tree planting on their property. In the case of landowners who do not want trees replanted on their property, both offices also have collections much like the state tree bank to allow for the planting of trees in other areas of their respective counties. Trees planted on property not legally accessible to Sacagawea Pipeline Company, LLC will be monitored by those individual landowners. For landowners that requested that the replacement trees/shrubs be planted on their property, the NRCS office will make a tree plan with each landowner, install a weed barrier which will also help with moisture retention, plant the trees, and monitor the trees for mortality for 3 years. Trees will be planted in the spring and monitored each fall. Any trees that are found to be dead will be replaced and monitored. Sacagawea Pipeline Company, LLC will be billed for all work performed by the respective offices. Trees placed in the “tree bank” will be planted at the discretion of each NRCS office. The tree counts, tree replacements, and trees to be banked are listed below by county:
