The Falkirk Mining Company has filed applications to renew and revise Surface Coal Mining Permit No. NAFK-9503 covering lands located in:

All or portions of Sections 29, 30, 31 and 32, T146N, R83W, and Section 36, T146N, R84W, and Sections 7, 18, 19, and 30, T145N, R82W, and Sections 4, 5, 6, 7, 8, 9, 10, 11, 12, 13, 14, 15, 16, 17, 18, 19, 20, 21, 22, 23, 24, 25, 26, 27, 28, 29, 32, 33, 34, 35, and 36, T145N, R83W, and Sections 1, 2, 12, and 13, T145N, R84W, and Sections 4, 5, 6, 7, and 9, T144N, R83W, and Sections 1, 2, 3, 10, 11, and 12, T144N, R84W, in McLean County, totaling 29,310.4 acres.

The five-year permit renewal will allow Falkirk to continue to operate within the existing permit area until April 17, 2021. The revision identifies the next 5-year coal removal subarea and updates legal information, operation plans, and reclamation plans in the permit.

You may submit written comments or objections on the proposed permit renewal and revision applications and their effects on the environment and on surface owners of the land in the permit area. You may request an informal conference with the Commission and the applicant on the renewal and revision applications. The reasons for requesting an informal conference must be stated in the request. Written comments, objections, or requests for informal conference must be made by February 29, 2016.

If there is an informal conference, you may request a formal administrative hearing on the Commission ruling on the application. Your request for a formal hearing must be made within thirty days of the Commission ruling on the application.
