RE: Roving Grain Buyer License

On December 16, 2015, the Commission passed a motion approving the roving grain buyer license application for Standard Commodity Management LLC. Enclosed is North Dakota Roving Grain Buyer License Number 3218. State law requires that a roving grain buyer have the buyer's license in possession at all times. Enclosed for your information are colored posters that address credit-sale contracts and procedures for resolving grain grade disputes.

State law requires that licensees submit a monthly report within 30 days of the end of each month, even if no business is conducted during a month. Information from the monthly reports pertaining to the volume of grain handled is **CONFIDENTIAL** and not a public record. If you file electronically, complete the fillable form, click on the "E-mail to the Commission" button and send the e-mail message that is automatically created.
