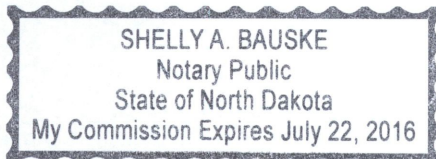

**Order Granting Continuance**

**February 25, 2016**

On February 23, 2016, Concerned Citizens of Stark County (CCSC) filed a Motion for Continuance, asking to continue the hearings in the captioned cases currently scheduled for March 2, 2016.

At the time of filing the Motion for Continuance, CCSC's Petition to Intervene filed February 12, 2016 was pending before the Administrative Law Judge.

On February 24, 2016, Brady Wind, LLC filed its response to the Motion for Continuance.

On February 25, 2016, following discussion at a Prehearing Conference held February 24, 2016, the Administrative law Judge granted intervenor status to CCSC.

The Commission has considered the Motion for Continuance, as well as Brady Wind LLC's Response. The Commission specifically finds good cause exists to grant the continuance. Since the Notice of Filings and Public Hearings for PU-15-690 and PU-15-797 were issued by the Commission on January 20, 2016, applicant Brady Wind, LLC has filed with the Commission substantial additional documentation of a technical nature, as late as February 19, 2016. Allowing CCSC additional time to prepare for the hearings is appropriate.

**Order**

The Commission orders the Motion for Continuance filed by Concerned Citizens of Stark County GRANTED.


