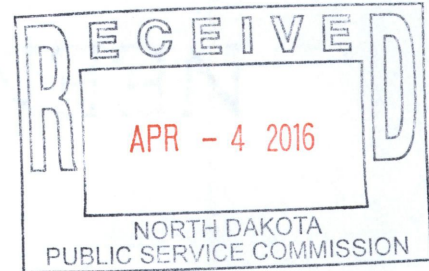


The materials delivered to you include:
