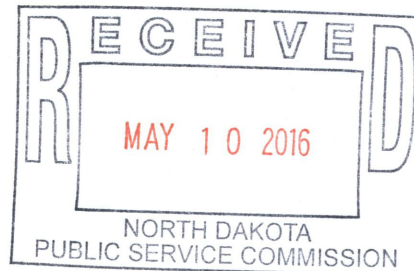

REQUEST TO WITHDRAW CONSOLIDATED APPLICATION

Pursuant to North Dakota Administrative Code Section 69-02-02-07(2), Cenex Pipeline, LLC (“Cenex”) submits this Request to Withdraw for its Consolidated Application for a Certificate of Corridor Compatibility and Route Permit and Waiver in Case No. PU-15-798. Cenex respectfully requests that the Public Service Commission grant permission for withdrawal of the application in this case in which the public hearing was held on March 29, 2016.

Cenex is withdrawing its application because the Raymond Township Board of Supervisors did not grant the zoning approval that was anticipated for the proposed Prosper Terminal Project. Cenex has therefore decided not to pursue the location set forth in the application at this time and is considering other options.


