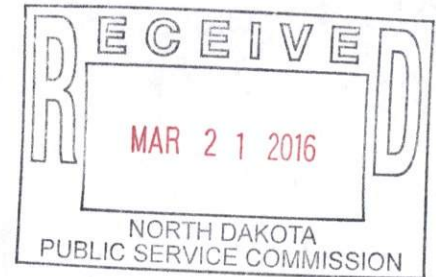

No. PU-2598-01-511.
