T143N, R88W, Mercer County, totaling 3,558.3 acres.**

The five-year permit renewal will allow Dakota Westmoreland Corporation to continue operating within the existing permit area until August 7, 2021. The revision identifies the next 5-year coal removal subarea and updates materials in the permit including legal information, operation plans, and reclamation plans. 
