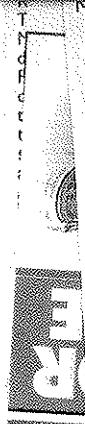

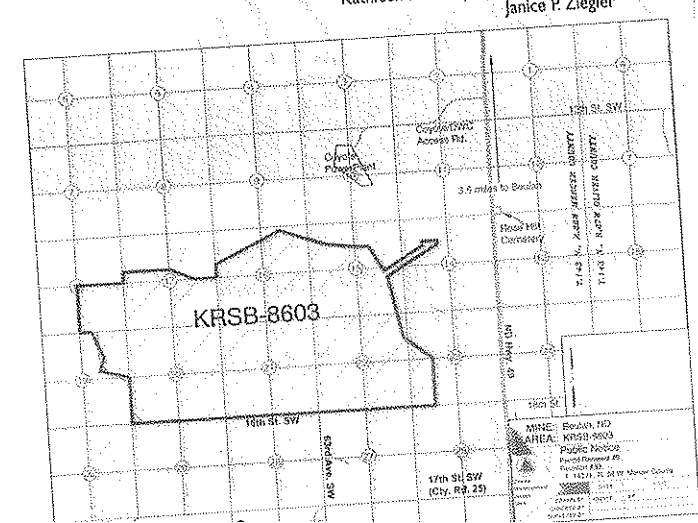

**NOTICE OF APPLICATION  
FOR REVISION and RENEWAL TO A SURFACE COAL MINE PERMIT**

Please take notice that Dakota Westmoreland Corporation, PO Box 39, Beulah, North Dakota 58523, has made application to the North Dakota Public Service Commission for Revision No. 30 and Renewal No. 6 to Surface Coal Mining Permit KRSB-8603. The permit area is located in Sections 14, 15, 16, 17, 18, 19, 20, 21, 22, and 23; T.143N., R.88W., Mercer County, North Dakota. The precise location and boundaries of the permit area are depicted on the accompanying map.

Permit KRSB-8603 encompasses 3,558.3 acres for coal excavation, mining and associated disturbance activities in support thereof. Revision No. 30 identifies the coal removal subarea that will be mined during the next 5-year permit term, and also updates the current permit to reflect changes necessary for the next permit term including the legal and financial sections, general operations and reclamation plans. Renewal No. 6 will allow mining and reclamation activities to continue during the next five-year permit term ending August 7, 2021.

This application is on file in the Office of the Director, Reclamation Division, Public Service Commission, State Capitol, Bismarck, North Dakota and the Office of the County Auditor, Mercer County, Stanton, North Dakota. This application may be viewed at these locations during normal business hours.

Any persons with an interest which is or may be adversely affected may file written comments, objections, or request an informal conference on the revision and renewal applications with the North Dakota Public Service Commission, 600 East Boulevard, Dept. 408, Bismarck ND 58505-0480, within 30 days of the last publication of this notice. Any request for an informal conference must include the reasons for the request.
