III. BASIC LOCAL SERVICE

G. RATES AND CHARGES

1. ACCESS LINE SERVICE

Rates for Residential and Business service are as follows:

Unlimited Calling Plan - Customers selecting unlimited usage are able to make and receive unlimited calls within the Nemont Extended Area Service (EAS) region as a local call, without any per-minute charges, simply by dialing a seven-digit telephone number.

Residential Unlimited Calling Plan \$26.00
Business Unlimited Calling Plan \$32.00

Measured Calling Plan - Customers selecting measured usage pay \$0.05 per minute for outgoing calls within the Nemont EAS region calling area. These customers benefit from two-way EAS because they are able to receive calls from other customers within the EAS region as a local call. Calls made between the exchanges listed in Nemont Tariff, Section III, Sheet 4 Rev. 1 are local calls and will not incur the \$0.05 per minute charge.

Residential Measured Calling Plan \$21.00 plus \$0.05 per minute
Business Measured Calling Plan \$27.00 plus \$0.05 per minute

Changes from one plan to the other after October 28, 2004 will incur a surcharge of \$8.50.

Measured calling Plan subscribers requiring call detail lists for those calls made within the EAS region will be charged an additional \$2.00 per month.

North Dakota exchanges (Ambrose and Fortuna) not included in the Nemont EAS have the following rates:

Residential \$18.00 (I)
Business \$26.00
