ONEOK Rockies Midstream, L.L.C. ("ONEOK") has received the letter dated June 8, 2016, from Victor Schock, Compliance and Competitive Markets Division, concerning the referenced North Dakota One-Call Complaint ("Complaint") received by the North Dakota Public Service Commission (Commission) on June 4, 2016, from Keith Ernest with Ernst Trenching, Inc. ("Ernst"), of Fargo, ND. ONEOK appreciates the opportunity to respond. This letter is to serve as ONEOK's written account of the events.

Account of the Events

One-Call Ticket # 16037531 ("Ticket") was transmitted to ONEOK's system at 6:49 p.m. on Tuesday, May 3, 2016. The locate deadline was Thursday, May 5, as provided in NDCC Chapter 49-23. The Ticket indicated that excavation was scheduled to commence on May 6 at 7:00 a.m.

On May 4, ONEOK's pipeline operator, John Lorebiecke, drove to the starting point described in the Ticket. He followed the instructions on the Ticket describing where the line was to be located. ONEOK's closest pipeline was approximately 1 mile away from the route described on the Ticket. Mr. Lorebiecke determined that ONEOK was clear on this locate and advised Jeff Kytle with Ernst that ONEOK was clear on the locate.

Both pipeline operators for ONEOK in the area of the locate request on the Ticket have worked with Ernst on 13 other locate requests in this area since April 2016. There have not been any problems with any of those locates. ONEOK knows of no basis for the Complaint. Ernst never contacted ONEOK concerning an abandoned pipeline in the area. Further, ONEOK does not have any abandoned pipelines in the area of this locate request.


