Hiland Crude, LLC (“Hiland”) has conducted a diligent search for records to document its compliance with the Commission’s November 2, 2011 Order concerning tree and shrub mitigation specifications. Hiland personnel recall that the trees and shrubs were planted in approximately 2014 but unfortunately, due to the passage of time, Hiland has been unable to locate complete documentation demonstrating when and where the plantings occurred pursuant to the November 2, 2011 Order. Hiland has located documentation demonstrating that 221 trees and shrubs were estimated to be impacted by the construction and therefore, the total number of trees and shrubs to be planted was 442. The details are included in Attachment 1.

Hiland has spoken with the McKenzie County Soil Conservation District (“McKenzie County”) regarding their program for PSC tree and shrub mitigation requirements. Hiland proposes to work with McKenzie County on a plan and locations to plant 442 additional trees and shrubs in the Spring of 2022 and then inspect them each September and submit a written report to PSC by October 1 for three years (2022, 2023 and 2024). Recent discussions with landowners on this project indicate that not all are agreeable to tree and shrub plantings on their property. As such, Hiland requests that alternate planting sites, located elsewhere within McKenzie County, be allowed and that McKenzie County be able to determine the variety of plants and shrubs to plant.
