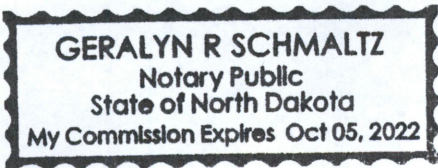

ORDER ACKNOWLEDGING AUTOMATIC DISCONTINUANCE OF BUSINESS

August 22, 2018

The Helmsman Group, LLC dba AgMark of Emeryville, California, operated as a roving grain buyer under license number 3214 issued by the Public Service Commission under the provisions of North Dakota Century Code Chapter 60-02.1.

On April 9, 2018, The Helmsman Group, LLC dba AgMark notified the Commission they were no longer going to conduct business in North Dakota.

On April 24, 2018, the link to the Request to Discontinue Business Roving Grain Buyer form was emailed to the licensee.

On July 24 and July 31, 2018, a follow-up email was sent to the licensee and on July 31, 2018, a phone call was made to the licensee requesting an update on the submittal of the Request to Discontinue Business form.

On July 31, 2018, an email was received from the licensee outlining their inability to file the Request to Discontinue Business form and acknowledging the automatic discontinuance of business.

Order

The Commission acknowledges:

1. Roving grain buyer license number 3214 issued to The Helmsman Group, LLC dba AgMark expired on July 31, 2018,
2. Business as a roving grain buyer in North Dakota was automatically discontinued effective August 1, 2018 for failure to file a roving grain buyer license renewal application in a timely manner and The Helmsman Group, LLC dba AgMark shall not conduct any further business under license number 3214.
