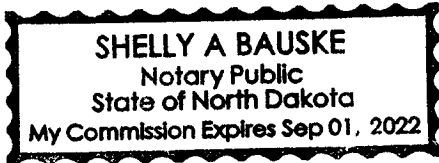

ORDER REINSTATING WAREHOUSE LICENSE

September 7, 2016

Flasher Farmers Union Grain & Oil operates a licensed public grain warehouse at Flasher, North Dakota, under license number 1063, issued by the Public Service Commission under the provisions of North Dakota Century Code Chapter 60-02.


On June 6, 2016, the Commission received cancellation notice on Flasher Farmers Union Grain & Oil's Warehouse Bond No. K09234536. The cancellation date of the grain warehouse bond was September 6, 2016. As provided in North Dakota Century Code section 60-02-09.1, the company's warehouse license was suspended effective August 6, 2016 for failure to file a new bond at least thirty days before liability ceases on the existing bond. Flasher Farmers Union Grain & Oil had until September 6, 2016, to procure and file an adequate bond or submit a written request for hearing. On August 25, 2016, the Commission received a replacement bond.

Order

The bond requirements have now been met and the Commission orders that:

1. Warehouse license number 1063 issued to Flasher Farmers Union Grain & Oil is reinstated, effective August 25, 2016, and
2. Flasher Farmers Union Grain & Oil is authorized to operate a public grain warehouse at Flasher as governed by North Dakota Century Code Chapter 60-02.
