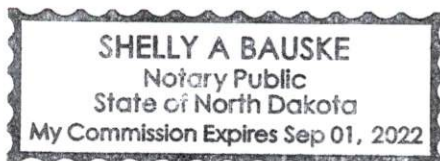

NOTICE OF INTENT TO REVOKE CERTIFICATE OF SITE COMPATIBILITY

December 15, 2021

The Commission's December 7, 2016, Findings of Fact, Conclusions of Law and Order (Order) in Case No. PU-16-539 issued Certificate of Site Compatibility No. 51 to Glacier Ridge Wind Farm, LLC (Glacier Ridge) for the location of Phase I of the Glacier Ridge Wind Farm with locations for up to 52 turbines plus three alternate turbine locations totaling up to 179.4 MW of generating capacity.

Construction began on December 14, 2016. On March 16, 2017, Glacier Ridge filed a construction progress report indicating that at 19 turbine locations, foundations were excavated.

The Commission's September 6, 2017, Findings of Fact, Conclusions of Law and Order (Order) in Case No. PU-16-539 issued First Amended Certificate of Site Compatibility No. 51 to Glacier Ridge to add Phase II of the Glacier Ridge Wind Farm with locations for up to 35 turbines plus nine alternate turbine locations totaling up to 120.75 MW of generating capacity.

On October 4, 2021, in response to a request for information, Glacier Ridge reported that the Glacier Ridge Wind Farm project has been cancelled and construction work will not resume. Glacier Ridge has decommissioned the project by backfilling all turbine foundation excavations and restoring the site to the condition that existed prior to the beginning of construction.

Based on the information enumerated above, the Commission intends to revoke First Amended Certificate of Site Compatibility No. 51 related to the Glacier Ridge Wind Farm.

Those interested are invited to comment in writing. Persons desiring a hearing must file a written request identifying their interest in the proceeding and the reasons for requesting a hearing. **Comments and requests for hearing must be received by January 19, 2022.** If deemed appropriate, the Commission can determine the matter without a hearing.
