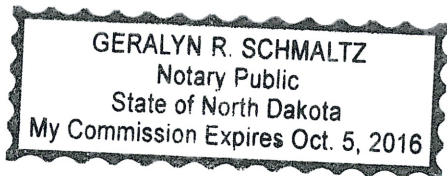

BP & Sons Grain and Storage, Inc. of Morden, Manitoba, Canada, operated as a roving grain buyer under license number 3208 issued by the Public Service Commission under the provisions of North Dakota Century Code Chapter 60-02.1.

In late May 2016, the Commission mailed a roving grain buyer license renewal application to BP & Sons Grain and Storage, Inc.

In early July 2016, the Commission electronically mailed a reminder to BP & Sons Grain and Storage, Inc. that a license renewal application had not been received.


A license renewal application was not timely filed by BP & Sons Grain and Storage, Inc. as provided in North Dakota Administrative Code section 69-07-02-03.




The Commission acknowledges:

1. Roving grain buyer license number 3208 issued to BP & Sons Grain and Storage, Inc. expired on July 31, 2016,

Business as a roving grain buyer in North Dakota was automatically discontinued effective August 1, 2016 for failure to file a roving grain buyer license renewal application in a timely manner and BP & Sons Grain and Storage, Inc. shall not conduct any further business under license number 3208, and
