NOTICE OF PRICE INCREASE

The Network Access Assessment charge (NAA) is assessed as a percentage of recurring charges for local and intrastate services (depending on service location), interstate and international services, data, IP-platform and cloud services, private-line services, and the Interstate Access Charge (IAC) and Interconnection Fee (ICF). Effective with the October bill cycle, the NAA is increasing from 10.95% to 11.95% (where applicable). More information can be found on our website at <http://www.integratelecom.com/fees>.
