
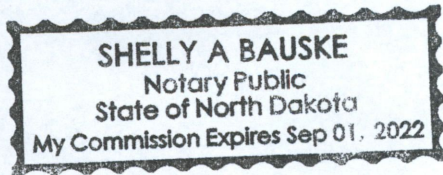

The Commission orders:


