Dear Mr. Nitschke:

Tesoro High Plains Pipeline Company LLC (THPP) files the accompanying tariff with an issue date of January 9, 2017 to be effective on January 20, 2017:

North Dakota P.S.C. No. 103 (cancels North Dakota P.S.C. No. 102).

THPP is filing North Dakota P.S.C. No. 103 to establish rates and routes to an interconnection with the DAPL Terminal in Johnson's Corner, McKenzie County, ND. Pursuant to agreement between THPP and its shippers, THPP North Dakota P.S.C. No. 103 also establishes a surcharge applicable to deliveries to Mandan, Morton County, ND.

No additional changes have been made to this tariff.



Pumpover Fee: When shipments are transferred from tank or truck facilities into the main line facilities of Tesoro High Plains Pipeline Company LLC, a charge of [U] 18.22 cents per barrel will be made in addition to the transportation rate stated above.

A \$0.10 per Barrel charge for electric power will apply to all deliveries at the following origination points: In T146N 93W: Section 11 SESW, Section 13 NWNW, Section 24 SWSW, Section 25 NWNW, and also the following locations in T145N 93W: Section 10 SWSE, Section 12 SWSW, Section 13 NWNW, and Section 15 NENW and also the following locations in T146N 92W: Section 19 SWSE, Section 30 NENW.

*The Gathering Rate for the Movement from Chimney Butte to Connolly Station is [U] 102.73 cents per Barrel. The Gathering Rate for movement on the Corral Creek Gathering System (points of origin upstream of Chimney Butte, for delivery into the Gathering System at

Chimney Butte) for up to [U] 2,900 Barrels per day (“bpd”) is [U] 34.06 cents per Barrel and the volume incentive rate for volumes greater than [U] 2,900 bpd is [U] 30.88 cents per Barrel.
