NOTICE OF RECEIPT OF RENEWAL AND REVISION APPLICATIONS

April 13, 2017

The Coteau Properties Company has filed applications to renew and revise Surface Coal Mining Permit No. NACT-9101 covering lands located in:

All or portions of Sections 5, 6, 7, 8, 9, 15, 16, 17, 18, and 21, T145N, R86W; and all or portions of Sections 1, 2, 3, 9, 10, 11, 12, 13, 14, and 15, T145N, R87W, Mercer County, totaling 8,427.5 acres.

The five-year permit renewal will allow Coteau to continue to operate within the existing permit area until June 30, 2022. The revision identifies the next 5-year coal removal subarea and updates other information in the permit including legal information, operation plans, reclamation plans and surface water management plans. The revision also adds 478 acres to the permit that are currently part of Permit NACT-9001. The renewal and revision applications and surface coal mining and reclamation permit may be inspected at:
