
Under North Dakota Century Code Section 28-32-44(2), when a Public Service Commission decision is appealed, the Public Service Commission shall notify the appellant of the estimated costs of preparing and filing the record. The appellant must then pay the Public Service Commission the amount estimated. If the actual costs are more than the estimated costs, the appellant must pay the difference. If the actual costs are less than the estimated costs, the Public Service Commission will refund the difference.

PLEASE TAKE NOTICE that because the existing record will be provided in an electronic format, there will be no costs for preparing and filing the existing record other

than the cost of transcribing the electronic record of the hearing. The cost for transcribing the electronic record is estimated to be \$1800. Please remit a check made out to the Public Service Commission in the amount of \$1800.
