
Gentlemen:

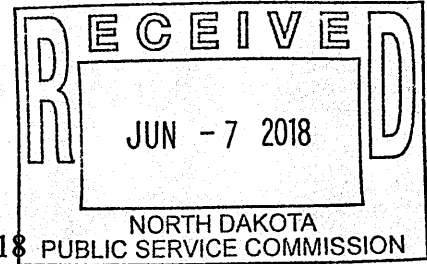
