AMENDMENT to Contract between the State of North Dakota, acting through its North Dakota Public Service Commission, "STATE," and Stantec Consulting Services Inc. (fka Wenck Associates, Inc.), "CONTRACTOR."

The parties agree to the following terms and conditions and expressly agree that if any of the following terms and conditions conflict with any of the terms and conditions of the Contract, then, notwithstanding any term in the Contract, the following terms and conditions govern and control the rights and obligations of the parties.

Whereas, Section 3, Term of Contract, states that the agreement will end on December 31, 2021, and

Whereas, Section 3, Term of Contract, states that the contract may be extended up to three times for an additional period of time not to exceed 12 months per extension, and

Whereas, the parties agree that Wenck Associates, Inc. was acquired by Stantec Consulting Service Inc., and Stantec Consulting Service Inc. will fulfill the obligations under this Contract as amended,

Whereas, the parties agree to extend the Contract for an additional 12 months,

Therefore, the contract is amended to change the expiration date to December 31, 2022.

All other terms of the Contract remain in effect.

This Contract Amendment is not effective until fully executed by all parties.
