Connie,

I would like to address a couple things about this ticket and hopefully clear up a few comments in your previous email.

Below is the location of work description which is indicated on the locate request:

**"WORK IS TO BE PERFORMED FROM 100 FEET EAST OF HIGHLAND ROAD WEST TO CROWN POINT ROAD IN THE GREEN SPACES. GREEN AREA WORK SHALL EXTEND NORTH AND SOUTH OF THE NEW CURB POURED ALONG OLD RED TRAIL, NORTH TO THE EXISTING HOME PROPERTY BOUNDARIES AND SOUTH TO 43RD ST. NW."**

The area Veit is requesting to be located runs along Old Red Trail from east of Highland Rd, running west to Crown Point Rd. It then goes on to indicate that from Old Red Trail, are area north to the home property boundaries and south to 43rd St NW. You indicate below their ticket was only written for the north side of the road but to me, the above description covers both the north and south side of Old Red Trail.

You also indicate below that stakes were not on site. Veit did not indicate on the locate request that there was a staked path, nor is one required by the ND One Call law.

For those reason, I don't see the ticket being written incorrectly.

The North Dakota Century Code (49-23-04, Paragraph 3, section a) states, "An operator (Century Link), within forty-eight hours, or any extension of that period, after receiving an excavation notice from the center, excluding Saturdays, Sundays and holidays, unless otherwise agreed to between the excavator and operator, shall locate and mark or otherwise provide the approximate horizontal location of the underground facilities of the operator."

49-23-04, Paragraph 3, section e states, "If the operator cannot complete marking of the excavation area before the excavation commencement time stated in the excavation notice, the operator shall promptly contact the center."

The center has no record of Century Link or your contract locator notifying them of an extension. Veit has informed me that no extension request was made by Century Link or your contract locator directly to them.

The law also states (ND Century Code 49-23-04, Paragraph 1, section j), "An excavator may begin excavation in a location if the location period (48 hours) has passed without notification of a requested extension..."

Veit can legally begin their excavation per the NDCC above. However, knowing there could be a Century Link facility in the area, it appears from the email thread that Veit contacted Century Link, provided a valid ticket number, and informed you that nothing has been marked well beyond the 48 hour locate period. Per North Dakota Century Code 49-23-04, paragraph 3, section j, "If in the course of excavation the excavator is unable to locate the underground facility or discovers that the operator of the underground facility has incorrectly located the underground facility, the excavator shall promptly notify the operator or, if unknown, the one-call notification center."

It IS NOT the responsibility of the contractor (Veit) to contact your contract locator. Your contract locator is not listed as the utility on the locate request nor does your contract locator own or operate the underground facilities within the excavation area.

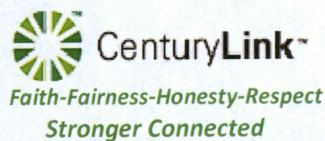
