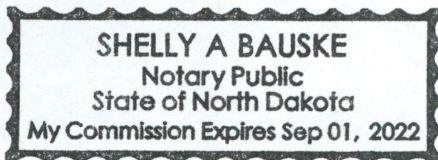

The Commission orders:


