



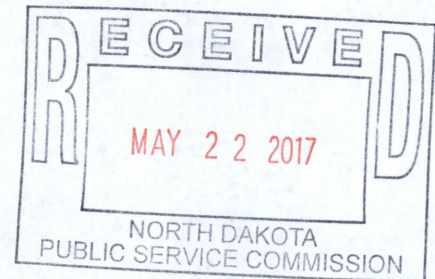

Dear Mr. Nitschke:

John Staurulakis, Inc. ("JSI") files the enclosed tariff material on behalf of North Dakota Intrastate Access Coalition North Dakota Tariff No. 1 issuing carriers ("issuing carriers") listed at Appendix A. Proposed revisions are made in compliance with current Federal Communications Commission ("FCC") rules governing intercarrier compensation. Proposed revisions also include maintenance revisions to update exchange groups as described more fully below. The proposed revisions bear an effective date of July 1, 2017. An original and six (6) copies are provided as well as an electronic copy.

National Exchange Carrier Association ("NECA") interstate switched access rates are expected to increase effective July 1, 2017, thereby increasing the capped rates which the issuing carriers must match for terminating access by July 1, 2017,<sup>1</sup> with the exception of two carriers as discussed in the following paragraph. The issuing carriers' rate tables established in 2012 to provide for the rate transition period through the year 2020 reflect proposed revisions resulting from NECA's increased switched access rates. Rates are based on the 1.119 percent interstate switched access rate increase as announced by NECA on April 24, 2017 (see Exhibit I). If NECA rates approved by the FCC differ from those proposed in this filing, rates will be adjusted to match the approved NECA rates. Issuing carriers' interstate terminating switched access rates are contained in NECA Tariff F.C.C. No. 5 which may be found at [https://www.neca.org/Tariff\\_5.aspx](https://www.neca.org/Tariff_5.aspx).



Nemont Telephone Cooperative, Inc. ("Nemont") and Missouri Valley Communications, Inc. ("Missouri Valley") will exit the NECA Traffic Sensitive Pool and will become issuing carriers for the Moss Adams F.C.C. Tariff No. 1 effective July 1, 2017. The Nemont and Missouri Valley traffic sensitive switched access rates effective July 1, 2017 have been established in compliance with FCC Transitional Access Service Pricing rules at Part 51, Subpart J of FCC rules for exiting the NECA traffic sensitive pool.<sup>2</sup> The Nemont and Missouri Valley interstate switched access rate calculations are provided at Exhibit II. If Nemont and Missouri Valley rates approved by the FCC differ from those proposed in this filing, rates will be adjusted to match the approved rates. The Moss Adams F.C.C. Tariff No. 1 may be found at <https://apps.fcc.gov/etfs/public/tariff.action?idTariff=989>.

Finally, this filing includes revisions to update or eliminate exchange groups as applicable to reflect current network configurations. Indications of changed or deleted material are limited to these exchange group updates or eliminations.

### **For your action** **CAF ICC data collection is open until May 15** **to review adjusted switched access rates**

April 24, 2017

To: General and pool contacts at TS pool members

#### **Switched access rates**

Commission rules require NECA to adjust capped interstate switched access rates effective on July 1, 2017, to reflect 2017 pool election changes. Pool election changes for the upcoming tariff year will increase these rates by 1.119 percent. The proposed terminating end office rate will be \$0.003567, which is \$0.0007 plus two-thirds of the difference between \$0.005 and \$0.0007 per minute. In the [CAF ICC website](#) (login required), we have modified the following for test period 2017-2018:

- interstate switched access rate levels,
- intrastate switched access rate levels for those companies with intrastate rates at parity with interstate rates,
- interstate terminating End Office access service rates to not exceed \$0.003567 per minute, and
- switched access revenues.

NECA will apply the 1.119 percent rate increase related to pool election changes to originating End Office rates and all transport rate elements. Rates are rounded up to the last significant decimal place for a 5 or greater and rounded down otherwise.

Other proposed July 1 interstate and intrastate monthly and nonrecurring switched access rates can be viewed in the CAF ICC Data Collection website in the *Study Area Intrastate Data* section by selecting the *Intrastate TRP at Rate Element Level* link. Your company's existing Local Switching and Local Transport rate band assignments will remain unchanged in the upcoming filing. **Adjusted intrastate rates, both end office and transport, need to be filed with state regulatory commissions.**

#### **Eligible Recovery and CAF ICC**

The forecasts of interstate switched access minutes, SLB and MLB lines have also been updated on the CAF ICC Data Collection website. The updated forecasts and the required switched access rate changes impact your interstate allocated switched access revenue, intrastate terminating switched access revenue, ER and CAF ICC support.

#### **Test period 2015-2016 true up**

The test period 2015-2016 true-up calculations currently do not reflect April settlements data. This true-up data will be updated after the April view of realized revenues is available in settlements and can be viewed when the CAF ICC Data Collection website re-opens on May 16. As indicated in our [February 16, 2017 letter](#) (login required), no revisions to switched access revenue data for the test period 2015-2016 will be accepted after April settlements lock (average schedule lock is on Monday, April 24; cost lock is on Wednesday, April 26).

#### **CAF ICC data update**

The CAF ICC website will remain open until **May 15** to allow for forecast updates and other changes. Companies will not be able to change any forecast data after May 15. Since no changes can be made after May 15, please review your inputs to be sure they are accurate.


**Data certification**

Blank certification forms will be available on the website for companies unable to certify online; these are **due to your region office by May 30**.
