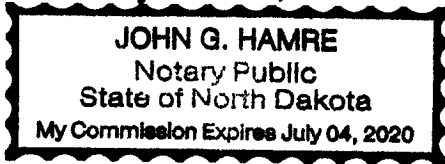

ORDER LIFTING SUSPENSION AND REINSTATING WAREHOUSE LICENSE

June 27, 2017

Preliminary Statement

Direct Grain, Inc. operates a licensed public grain warehouse at Wyndmere, North Dakota, under license number 1150, issued by the Public Service Commission under the provisions of North Dakota Century Code Chapter 60-02.

On March 27, 2017, the Commission received cancellation notice for Direct Grain Inc.'s Warehouse Bond No. 929568509. The letter indicated that the cancellation date for the grain warehouse bond is June 29, 2017.

On May 31, 2017, as provided in North Dakota Century Code section 60-02-09.1, the Compliance Division suspended the company's warehouse license effective May 31, 2017 for failure to file a new bond at least thirty days before liability ceases on the existing bond.

Also, on May 31, 2017, the Compliance Division notified Direct Grain, Inc. that it had until June 28, 2017 to procure and file an adequate bond.

On June 16, 2017, the Commission issued an Order Suspending Warehouse License and Notice of Opportunity to be Heard.

On June 20, 2017, the Commission received a bond reinstatement letter.

The bond requirements have now been met.

Order

The Commission orders:

1. The suspension of warehouse license number 1150 issued to Direct Grain, Inc. is lifted effective June 20, 2017.


2. License No. 1150 issued to Direct Grain, Inc. is reinstated effective June 20, 2017.

3. Direct Grain, Inc. is authorized to operate a public grain warehouse at Wyndmere, North Dakota as governed by North Dakota Century Code Chapter 60-02.
