Dear Mr. Nitschke:

On June 30, 2017, the North Dakota Public Service Commission (“Commission”) issued its Order on Recommended Findings of Fact, Conclusions of Law and Order (“Order”) granting Certificate of Corridor Compatibility Number 199 and Route Permit Number 210 to Arrow Field Services, LLC (“Arrow”) for the project. The Certification Relating to Order Provisions – Transmission Facility Siting (“Order Certification”) executed by Arrow was incorporated by reference and attached to the Order.

Since issuance of the Order, Arrow has determined that a route adjustment and modification of the transmission facility are necessary to facilitate third party interconnects.
