A **Public Hearing** on the application in Case No. PU-17-372 is scheduled to begin **March 21, 2018 at 9:00 a.m. CDT** in the Commission Hearing Room on the 12th Floor of the **State Capitol, 600 East Boulevard Ave, Bismarck, North Dakota 58505**.

On October 10, 2017, Northern States Power Company (NSP) filed an application for an advanced determination of prudence to build, own and operate the proposed 302.4 MW Dakota Range I and II wind projects to be located near Watertown, South Dakota.

The issues to be considered in this matter are whether NSP's proposed resource additions are prudent.
