**Variance Permit Request To:**

Use the atmospheric tank prover enumerated above as a standard to certify Magellan's commercial measuring devices. This prover is not certified as traceable by a NIST-recognized metrology laboratory [N.D. Admin. Code § 69-10-03-02].

**Temporary Variance Permit Conditions:**

- The atmospheric tank prover must be tested at least once every three years by Meter Engineers, Inc. using the water draw method and using testing equipment that is traceable to and certified by a NIST-recognized metrology laboratory with the exception of the thermometers. The prover must be certified as compliant with American Petroleum Institute standards for atmospheric tank provers.
- The Commission must be notified at least 10 days prior to commencement of a prover test to allow a representative of the Commission the option to witness the testing process.

- A copy of the atmospheric tank prover metrology must be filed with the Commission after each recertification.
- Except for the specific variance granted by the permit, all applicable North Dakota Laws and Rules must be followed.
- The enclosed Temporary Variance Permit must be posted near the prover in a place clearly visible to the interested parties.
- Prior to the expiration of your registered service company permit, you must complete and submit the Application for Registration as a Registered Service Company. The application must include current atmospheric tank prover metrology and a written request for a variance permit if the metrology was not performed by a NIST-recognized metrology lab.
- Failure to comply with the variance permit conditions may result in revocation.
