Otter Tail Power Company (Otter Tail) respectfully submits this correction to our interim rate tariff compliance filing in response to the North Dakota Public Service Commission's (Commission) December 20, 2017, Order on Interim Rates (Order) in this proceeding. Through this filing, Otter Tail seeks Commission approval of this amended schedule per the order dated December 20, 2017 with bills effective on and after January 1, 2018.

This filing provides the Commission with the corrected Page 1 of Rate Schedule 11.04, Outdoor Lighting, in legislative form. It provides the correct rate amount for the updated base fuel portion of the rate during the interim period based on the correct kwh amount used for that light type.

Otter Tail has verified that the billing of lights under this schedule has been correct since approval of the effective date of January 1, 2018. This error is limited to the presentation of the rate schedule only. Customer bills were not impacted.
