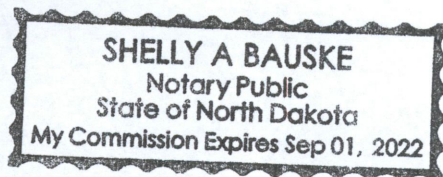

**NOTICE OF RESCHEDULED HEARING**

**March 14, 2018**

A previously scheduled **Public Hearing** on the applications for Case No. PU-17-483 originally scheduled for March 6, 2018 was cancelled due to inclement weather and is **rescheduled to begin April 12, 2018, at 9:00 a.m. Central Time, at The Ernie French Center, NDSU Williston Research Extension Center, 14120 Hwy. 2, Williston, North Dakota 58801.**

ONEOK Rockies Midstream, L.L.C. (ONEOK) has filed a consolidated application for a certificate of site compatibility and a route permit concerning the location of approximately 45 miles of 12-inch pipeline existing in McKenzie and Williams Counties, North Dakota, as shown on the attached map. ONEOK is proposing to convert the existing pipeline from a natural gas gathering pipeline to a transmission pipeline capable of transporting 50,000 barrels per day of natural gas liquids.

ONEOK also filed an application for waivers of procedures and time schedules established under North Dakota Century Code sections 49-22-16(2)(d), 49-22.1-05, 49-22.1-10, 49-22.1-06, 49-22.1-07, and North Dakota Administrative Code section 69-06-01-02 and chapter 69-06-06, regarding notice periods, separate filings, separate notices, and separate hearings on such applications.

The issues in the application for waiver of procedures and time schedules are:

1. Are the proposed facilities of such length, design, location, or purpose that they will produce minimal adverse effects and that adherence to applicable procedures and time schedules may be waived?
2. Is it appropriate for the Commission to waive any procedures and time schedules as requested in the application?

The issues in the consolidated application for a certificate of corridor compatibility and a route permit are:

1. Will the location and operation of the proposed facility produce minimal adverse effects on the environment and upon the welfare of the citizens of North Dakota?

2. Is the proposed facility compatible with the environmental preservation and the efficient use of resources?
3. Will the proposed facility location minimize adverse human and environmental impact while ensuring continuing system reliability and integrity and ensuring that energy needs are met and fulfilled in an orderly and timely fashion?

If determined that a waiver of procedures and time schedules is appropriate, the Commission may consider the application for a corridor certificate and route permit without further notice.

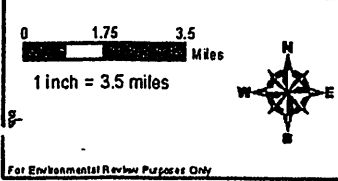
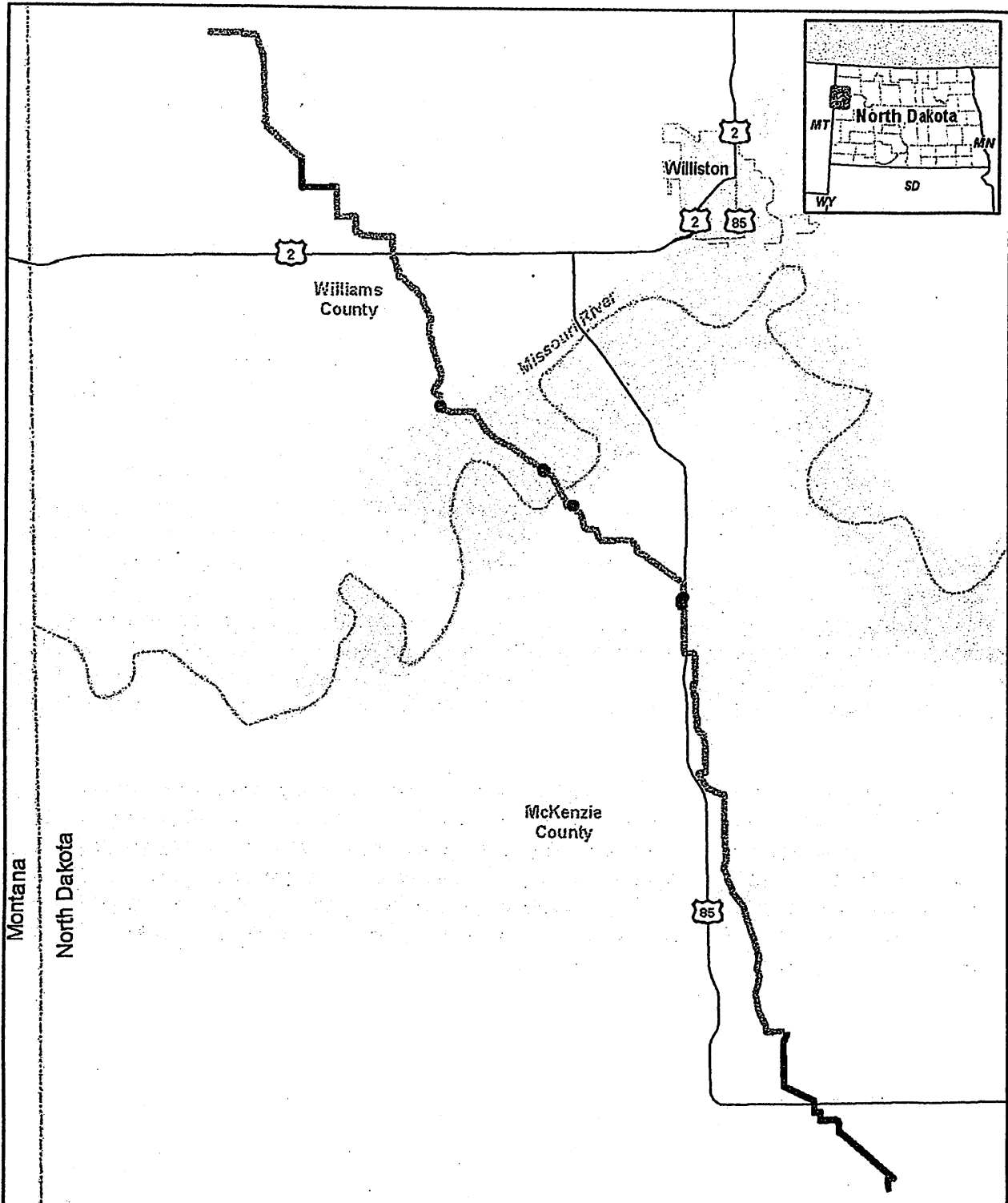
