Lifeline free minutes, units and data are automatically posted each month on the Lifeline customer's service date. There is no roll over of minutes. Tribal plan only available to eligible customers who reside on Federal recognized Tribal lands. Services are for personal use only. All usage is subject to the Acceptable Use Policy.
