I Scott Skokos hereby declare the following:

1. I, Scott Skokos, am the Executive Director of the Dakota Resource Council. I direct the organization’s oil and gas program and am involved directly with DRC’s day-to-day operations.

2. Dakota Resource Council was originally formed in 1978 to protect North Dakota’s land, air, water, rural communities and agricultural economy. One of Dakota Resource Council’s enduring issues—since its founding—has been advocacy to promote responsible oil and gas development by ensuring compliance with applicable laws. The mission of DRC is to form enduring, democratic local groups that empower people to influence decision-making processes that affect their lives.

3. Dakota Resource Council has over 900 members in good standing across North Dakota, including numerous members who are concerned about improper permitting and siting of the Davis Refinery near Belfield, North Dakota.

4. Dakota Resource Council's internal affiliate, Badlands Resource Area Council, has 35 members, many living within 10 miles of the proposed Davis Refinery. Members of Dakota Resource Council and the Badlands Area Resource Council are also concerned about improper permitting and siting of the Davis Refinery near Belfield, North Dakota and the associated impacts.
