
RE: Roosevelt Gas Plant

As you know, at the hearing to consider the request of Hiland to expand the capacity of the Roosevelt Gas Plant, I was granted the opportunity to testify. I explained to the Commission that I was disappointed that no one from Hiland had met with me to discuss the planned expansion. I also explained some of the operational activities at the plant that I considered to be a problem.
