Dear Commissioners:

Aurora Wind Project, LLC has proposed to include North Dakota School Trust Lands (Trust Lands) within its pending request to the North Dakota Public Service Commission (NDPSC) for a wind farm permit for the proposed Aurora Wind Farm, in Williams County, which was authorized by the Board of University and School Lands (Board). The primary responsibility of the North Dakota Department of Trust Lands (NDDTL) is to manage the permanent educational trust funds and assets under the control of the Board, as outlined in the North Dakota Constitution. These assets include 1.8 million mineral acres and 631,805 surface acres that are managed to provide revenue to schools (grades K-12) through the Common Schools Trust Fund.

In September of 2018, Tradewind Energy, Inc. and NDDTL surface division staff met in the field to site turbine locations, access roads, wind collector line locations, permanent power performance tower and wind electric transmission line locations. Although the Trust Lands tracts within the proposed Aurora Wind Farm are unbroken grassland, these grassland tracts are positioned in a fragmented landscape (non-contiguous grassland) surrounded by cropland. The siting of the proposed wind farm infrastructure was conducted in a manner to address NDDTL's concerns and minimize potential environmental impacts, while maximizing NDDTL's ability to generate revenue for the Trust.

Although NDDTL is in preliminary negotiations with Aurora Wind Project, LLC, no agreement has been reached. The Board prefers to wait until all local and state approvals have been granted before completing easement negotiations and therefore, has not considered any request for approval. NDDTL is authorized to negotiate with Aurora Wind Project, LLC, and submit a recommended easement and terms for Board consideration should the NDPSC approve the project.
